# Because **equity** is still an **issue** Thursday, April 24, 7:30pm Bethlehem Lutheran Church

To match men's earnings for 2007, women will have to work from January 2007 to April 2008—an extra four months. But Equal Pay Day is not just about disseminating information, it is also about mobilizing around the issue, to educate your community and continue the process of change. The wage gap between men and women persists. In 2005, women earned only 77 cents on the dollar to their male counterparts. Over a working lifetime, estimates of what this wage disparity costs the average American woman and her family range from \$440,000 to \$2 million. In 2004, a typical college-educated woman working full-time earned \$31,223 a year, compared to \$40,798 for a college-educated man—a stark difference of \$9,575. Since its founding in 1881, the American Association of University Women has been committed to promoting equity for all women.

Come to our meeting and wear red to signify the fact that women are in the red when it comes to wages. Awareness of the issue is step one in determining what each of us can do to promote pay equity.

One thing we can do right now is contribute to AAUW's Legal Advocacy Fund via our April non-event.

#### Non-event for the Legal Advocacy Fund

It's spring and we all welcome a break from fund raising – just think no baking, no phoning, no organizing, just write a check to the Legal Advocacy Fund (suggested donation \$5 to \$10). You will have done a world of good and Carroll Thomas our hard working Educational Foundation chair will thank you.

The Legal Advocacy Fund is a part of the Educational Foundation and helps students, faculty, staff, and administrators in higher education challenge discriminatory practices such as sexual harassment, denial of tenure or promotion, **pay inequity**, and inequality in women's athletics programs. Currently LAF supports 14 lawsuits and has awarded \$32,500 for FY2008. Among its successes, on September 20, **Laura Violand** prevailed against George Washington University's appeal when the appeals court judge upheld her \$280,955 jury award for back-pay damages. This decision is a major victory in light of the recent U.S. Supreme Court decision in *Ledbetter v. Goodyear Tire and Rubber Company*.

Another thing we can do right now is to support AAUW NM's coalition of women's groups formed to urge Senator Domenici to support of The Ledbetter Fair Pay Restoration Act (S. 1843). This has passed the house and currently has 36 senate cosponsors (including Senator Bingaman). This is the number one AAUW public policy priority right now and would restore the deadline for filing pay discrimination cases to 180 days following the last discriminatory pay check, rather than 180 days following the hiring or pay raise decision. We will have postcards available at the meeting. If you are unable to attend the meeting, call or e-mail Senator Domenici. (mailto:Senator\_Domenici@domenici.senate.gov) At the meeting, we will watch two short videos produced by the association that deals with the pay equity issue. The second video called Tech Savvy addresses the issue of women working lower paying jobs because they do not have the required math and science skills for the more technical, better paying jobs.

Also, Helena Whyte will lead a discussion of the book <u>Nickel and Dimed</u> by Barbara Ehrenreich. The author went 'underground' to do investigative reporting by working at low paying jobs thereby experiencing living poor and trying to make ends meet. Helena says, "There are at least 4 issues presented in this book: lack of health insurance, inadequate leave policies, low-wage jobs are often more strenuous and prone to injury, and the inadequacy of the minimum wage." From my point of view this book is relevant to pay inequity for women because displaced home makers who may be well educated, but have not been in the labor force for many years are forced by necessity to take jobs that are minimum wage or close to it."

This meeting will be a relevant lead into the <u>AAUW-NM Spring Convention in Rio Rancho</u> on April 26, 2008. Catherine Hill one of the co-authors of <u>Behind the Pay Gap</u> (<u>http://www.aauw.org/research/upload/behindPayGap.pdf</u>) will be presenting updates to and insights into her research.
