January Program Legislative Preview Thursday, January 12, 7:00 pm Fuller Lodge

AAUW and the League of Women Voters co-host the annual Legislative Preview. Speakers include our Representative Jeannette Wallace and Senator Richard Martinez, who will give an overview of the coming short legislative session; Los Alamos County Clerk Mary Pat Kraemer on legislative actions proposed by the interim committee on election reform; and Craig O'Hare of the New Mexico Energy, Minerals and Natural Resources Department, on the solar tax credit proposal.

The Election Reform Task Force was a legislative interim committee, but unlike most committees whose members are legislators, this committee was set up by the Legislative Council Service and about half of its members are not legislators. The membership included members of the executive branch and the public as well as NM senators and representatives. The committee will propose some legislation for the upcoming short session. Most of what the committee is proposing consists of clean-up language for the huge bill that passed in the last session. That bill left unresolved large issues having to do with recounts and audits and voter ID. The committee anticipates that the task force will continue next year and will ask for the money to continue in this session.

The League has also invited Jeanne Bassett of the New Mexico Public Interest Group, NMPIRG, to speak on predatory lending and the other two NM senators (Cisneros and Griego) who represent parts of Los Alamos County.

Our branch will provide refreshments and pays half the rent on Fuller Lodge. Those of you who have signed up to bring refreshments will be contacted.

The relevant section now reads: Individuals eligible to be admitted to membership are those holding an associate or equivalent, baccalaureate or higher degree from a regionally accredited educational institution, a degree from a foreign institution recognized by the International Federation of University Women (IFUW), or a foreign degree acceptable as a basis for admission by graduate schools at regionally accredited universities of the USA; such membership shall be granted upon payment of Association, state, and branch dues.
