Los Alamos Branch of AAUW and the Nereson Family are offering an opportunity to honor Jean Nereson, an elementary school teacher for fifty years in Los Alamos County Public Schools and active AAUW member. Jean was respected and loved by her students, and she dedicated her 50+ year career to their education and well-being. To honor Jean a memorial fund has been established through the Los Alamos Public Schools Foundation, which will collect and administer the fund at no cost. The Foundation is a 529A organization and **all donations are tax deductible**. The Nereson Family will match up to \$20,000. The money will be given to purchase books for each of the Los Alamos elementary school libraries. We hope the response will allow the fund to purchase books for up to five years.

A RESOLUTION SUPPORTING THE UNIVERSITY OF NEW MEXICO-LOS ALAMOS IN THE SPECIAL ALL-MAIL ELECTION FOR A MIL LEVY INCREASE

WHEREAS, the American Association of University Women advances equity for women and girls through advocacy, education, philanthropy, and research; and

WHEREAS, the American Association of University Women Public Policy Principles for Action hold that quality public education is the foundation of a democratic society and the key to economic prosperity and gender equality; and

WHEREAS, the American Association of University Women advocates for adequate and equitable funding for quality public education for all students and increased support for and access to affordable higher education for women and disadvantaged populations; and

WHEREAS, the University of New Mexico Los Alamos branch campus leads all New Mexico branch campuses in performance indicators as defined by the New Mexico Association of Community Colleges, including the highest three-year graduation rate of 62%; and

WHEREAS, the University of New Mexico Los Alamos branch campus provides exceptional instruction from highly educated faculty, 67% of whom hold PhD degrees;

NOW, THEREFORE, BE IT RESOLVED that the American Association of University Women Los Alamos Branch supports the University of New Mexico-Los Alamos in urging the voters of Los Alamos County to cast a yes vote to the question of a college district tax for UNM-LA in the special all-mail election on September 17, 2013.
