At our Rancho de Chimayo lunch, June Gladney explained how LA Cares works. It is an entirely volunteer organization and 97% of the funds it receives go directly to providing food and other help to Los Alamos residents, primarily the homeless and those at risk of becoming homeless. The number of families helped as of early December in 2014 is 126.

As a result of careful shopping and some serendipity, we have \$55 left in the fruit fund. I intend to buy a case or two of fruit for the January distribution.

Dust, Drought, and Dreams Gone Dry

Our **February branch meeting** comes with some homework. On **Tuesday, Feb. 10**, we will facilitate two community-wide discussions of Timothy Egan's award-winning history of the Dust Bowl, *The Worst Hard Time*. We hope you will read—or reread—Egan's book and join us either **at 1:00 or 6:30 pm** in Mesa Public Library's upstairs conference rooms to discuss it.

Our branch agreed to facilitate these book discussions in support of the library's application to host a traveling exhibit—**Dust, Drought, and Dreams Gone Dry**—about the epic drought that devastated the Great Plains in the 1930s. Mesa Library is one of only 25 libraries nationwide chosen by the American Library Association for the exhibit, which combines letters, oral histories, photos, maps, and individual voices to tell the story of the human and environmental impact of the Dust Bowl.

Both book discussion meetings will begin with a tour of the exhibit. Then we will return to the conference room to discuss what impressed us from Egan's telling chronicle of those who survived the Dust Bowl. As part of the ALA exhibit, we also have access to informative online resources:

- Oklahoma State University's "Women in the Dust Bowl": oral history archives of interviews with people who lived through the Dust Bowl. The website provides both transcripts and recordings of the interviews, so you can either read or listen to their stories.

So check out *The Worst Hard Time* from the library or pick it up as an e-book. And delve into the online resources available to us. Then come to Mesa Public Library on Feb. 10 and share what you've learned about, and from, the Dust Bowl.
