President's Column by Helena Whyte Title IX at 45, Executive Summary

from National Coalition and Girls in Education (NCWGE) 2017 Report

In the 45 years since Congress passed Title IX of the Education Amendments of 1972 the effects have been far-reaching. Many challenges to equity in education remain. Gender stereotyping continues to limit opportunities in Career and Technical Education (CTE). Women still face bias in STEM in academia and in computer and engineering fields. Sexual harassment and assault are persistent problems across the education spectrum. Ensuring that Title IX protections are strengthened, not weakened, is critical.

The benefits of equal access to education extend beyond students to their families and their communities. Education attainment drives both employment and wage growth in the US. Even after 45 years, adherence to Title IX'S provisions is not universal. Some schools fail to designate a Title IX coordinator. Poor tracking of what is happening in schools also causes concern. Some schools refuse to adhere to the law. These lapses lead not only to discrimination but may also lead to a hostile school environment that impedes learning.

These are the overarching recommendations for continued progress:

- 1. Awareness. Put communication mechanisms in place to ensure school community members understand students' rights.
- 2. Information. Schools at all levels must improve their data collection and reporting. Better tracking in sexual harassment, school climate, and graduation rates for pregnant and parenting students will help in developing effective policies. More transparency around participation in athletics, CTE, and STEM will increase understanding of the issues.
- 3. Enforcement. Granting agencies should conduct regular and random Title IX compliance reviews.

- OCR must enforce Title IX and promptly investigate complaints.
- 4. Enhancement. Additional guidance is needed to ensure the rights of LGBT students and more clearly restrict the use of single-sex programming. Greater funding for gender equity efforts, including enforcement of existing legislation, will help ensure that schools provide a learning environment in which all students can thrive.

In October, I will review what is working in STEM and recommendations for improvement from the report.
