The LWV-AAUW Legislative Preview will be held in person for the first time in three years! It will take place in Fuller Lodge on Thursday, January 5, from 7:00 to 9:00 p.m. Come at 6:30 for refreshments and to socialize.

Our legislators – Representative Christine Chandler, Senator Leo Jaramillo, and Senator Roberto Gonzales — will be speaking. In addition, Kristina Fisher will explain the education reform package that Think New Mexico will be promoting during the legislative session.

All of the speakers will answer questions from the audience. Margo Batha will represent our branch as moderator for the Preview.

The 2023 New Mexico Legislative Session will begin in Santa Fe at noon on January 17 and continue for 60 days, ending at noon on March 18.

On Legislative Advocacy Day, Monday, January 30, we will have an information session with fellow advocates of Paid Medical and Family Leave, (PMFL). Plans are to meet from 10-11:30 at Morgan Hall in the State Land Office, a block from the Roundhouse. Sylvia Fink is in charge of mobilizing our Advocacy Team to contact individual legislators. She will disseminate the talking points from the PMFL Task Force Final Report presented to the Legislative Finance Committee (LFC).
