# **Strengthening Education and Career Pathways**

This year we have a short session where only budget items and items on the governor's call will be germane. Education spending accounts for over **half** of our state's budget, so we know it is always germane. We have made historic investments to improve early childhood programs, teacher salaries, scholarships, and much more, but we still remain at the bottom in terms of outcomes. We are especially concerned about math and science education and the lack of coordination between high school, post-secondary education, and careers. This year we are honored to have four professional women share their perspectives on the challenges, opportunities, and policy recommendations with us. Here's a snapshot of the program.

At 10 am, State Land Commissioner **Stephanie Garcia Richard**, former state representative, math teacher, and district curriculum director, will briefly explain how the distributions from NM's immense Land Grant Permanent Fund and the Severance Tax Permanent Fund support our early childhood programs, pre-K-12 education, and other designated state beneficiaries. At 10:15, **Dr. Lina Germann**, SFCC Board Member, founder and former STEM Santa Fe Director, and AAUW-Santa Fe member for 18 years, will talk about ways to engage youth in STEM careers and develop partnerships with community groups, parents, volunteers, scientists, businesses, and higher ed. At 10:30 **Dr. Kersti Tyson**, LANL Foundation's Director of Research and Evaluation, will discuss legislation and programs aimed at improving math instruction and learning outcomes. Kersti and her colleagues recognize that the way math is currently taught contributes to our alarmingly low math proficiency scores, our high dropout rates, and our severe shortages of science, engineering, health care, and technology professionals.

Handouts about math instruction, dual credit, and the Foundation's vision that were presented at the Legislative Education Study Committee's July meeting are available here: <u>https://nmlegis.gov/Committee/Handouts\_List?CommitteeCode=ALESC&Date=7/</u><u>26/2023.</u> Kersti will share her insights on math methods instruction from her experience as a Teacher Education faculty member at UNM and NNMC, and her former administrative position at PED.

At 11 am, **Kristina Fisher**, Associate Director of **Think NM**, will discuss their legislative proposals to reduce elementary class sizes, improve teacher education training, require school board candidates to report significant campaign contributions, and require school board members to get more annual training in budgets, student performance, educator accountability, and other matters. First in her UNM Law School class, recipient of a national Truman Fellowship, Kristina is known for her thorough research and expertise on education policy.

We have worked with our premier statewide nonpartisan Think Tank in some of their past successful legislative efforts, including repealing taxes on food, ending predatory lending, and creating the Strategic Water Reserve. We will continue to advocate along with Think NM to oppose misguided legislation to reduce graduation requirements from 24 to 22 credits and eliminate Algebra 2. Knowing how essential Algebra is for STEM careers and competitive colleges, we believe that schools can offer relevant, rigorous options, including practical math and/or financial management, foreign languages, civics, and career pathways.

We invite you to join the Advocacy Team (**A-Team**) and help us testify on legislation aligned with our national and state Public Policy Priorities for 2023-25 (reprinted below). We need a full team to follow legislation, cover committee hearings, and speak for AAUW on what we support or oppose.
