# March Branch Meeting Carla Rachkowski, Director of Operations of the Regional Development Corporation Mesa Public Library, Upstairs Meeting Room Thursday, March 14, 2024, 6:30 pm

The Regional Development Corporation (RDC) is a private non-profit organization dedicated to improving economic development in Northern New Mexico. The RDC provides private investment opportunities and technical assistance to facilitate job growth and diversify the economies of communities in the following seven counties: Los Alamos, Mora, Rio Arriba, Northern Sandoval, San Miguel, Santa Fe, Taos, and the municipalities and Native American Pueblos therein. Current funders include Los Alamos County, New Mexico Manufacturing Extension Partnership, and Triad National Security LLC.

Ms Rachkowski will discuss the RDC's four key areas of focus. She will share success stories, challenges and future plans.

The RDC's four key areas of focus are:

**Business Retention & Expansion** through business outreach and direct investments. The RDC provides technical assistance that offers access to free, individualized support, mentoring, training, and workshops to help businesses grow and succeed. The RDC provides direct investments: grants and no-interest loans.

**Economic Development Capacity Building** through the Regional Economic Development Initiative (REDI) which supports communities and Pueblos. REDI focuses on regional collaboration, business development, workforce, climate change & renewables, housing and broadband infrastructure, and funding.

**Workforce & Education** through identifying and addressing education and training needed to develop a well-educated regional workforce by providing internships and apprenticeships.

**Partnerships and Professional Services** to acknowledge that our partners are a critical component in addressing the needs of small businesses. The RDC works with other organizations in a variety of ways, including providing funding through sponsorships for regional events, facilitating community roundtables and events, and hosting essential business resource events.

#### **Legislative Report**

Passed and awaiting governor's signature:

HB 129 now imposes a 7-day waiting period on firearm purchases by law-abiding citizens, including concealed handgun licensees and anyone else who passes a firearm background (NICS) check.

SB 5 bans open carry in and around polling places and at ballot drop boxes.

SB 137 upgrades the training and transparency of local school boards.

HB171 specifies graduation requirements, requiring 24 credits, with financial literacy as an elective required at each school.

HB151 requires state-funded post-secondary educational institutions to adopt policies addressing affirmative consent and prevention of sexual assault, domestic violence, dating violence and harassment and stalking.

Although the Paid Family and Medical Leave Act passed the Senate but fell two votes shy on the House floor, Rep. Christine Chandler is optimistic that it will make it across the finish line next year. She also noted that two green-energy bills that she co-sponsored made it to the Governor's desk. Both are steps toward promoting clean energy across the state.
